

The Melbourne Prize Trust offers the Melbourne Prize for Literature 2012, Best Writing Award 2012 and Civic Choice Award 2012 as one of the most valuable literary awards in Australia.

This document provides details of the prize and awards, general entry information, key dates and the entry form to be used for making an application. This year a residency at The University of Melbourne will be offered along with Qantas international air travel, provided to the recipient of the Best Writing Award.

To showcase the work of the finalists and enable the public to engage with the abundant literary talent in Victoria, the finalists work will be exhibited at Federation Square between 5 and 19 November 2012. The public will have an opportunity to vote for their favourite finalist to win the \$5,000 Civic Choice Award 2012 both

online and in the free catalogue.

In 2008, Melbourne was designated by UNESCO as an international City of Literature. The designation recognises the importance of literature to the city and the state and the central role that writers have played, and continue to play, in the cultural life of our community.

The Melbourne Prize for Literature 2012 and associated awards support Melbourne's status as a UNESCO City of Literature, recognising and rewarding writing talent in our state. We are proud to have the Victorian Government as a partner through its City of Literature initiative.

With the support of the City of Melbourne and our partners and patrons this year, we look forward to providing opportunities for writers and demonstrating the importance of literature in a vibrant and creative community. The Trust is pleased to recognise 2012 as the National Year of Reading.

Prize & Awards

Melbourne Prize for Literature 2012 \$60,000

The Melbourne Prize for Literature 2012 is for a Victorian author whose body of published or produced work has made an outstanding contribution to Australian literature and to cultural and intellectual life.

The author's work can include all genres and forms, for example, fiction, non-fiction, essays, plays, screenplays and poetry. There is no age limit for this prize.

The Prize is supported by The Vera Moore Foundation, The Tallis Foundation and the Melbourne Prize Trust.

What you need to know to enter this prize

- Authors can apply for this prize in their own right or be nominated by publishers, agents or private individuals.
- A separate entry form and fee must be provided for each additional application or nomination.
- / All work entered in this prize must have been published or produced by the closing date of entries on 16 July 2012.
- / This prize will be given to a single author. No group entries are permitted.
- / A shortlist of up to five (5) finalists will be announced on 5 September 2012 at melbourneprize.org and displayed at the Federation Square finalist exhibition. The recipient of this Prize will be announced on 7 November 2012 and published on the Prize website.

Material required for this prize

Please provide six (6) stapled A4 copies of the following support material:

- / CV including a summary of the author's published or produced work – maximum 2 x A4 pages.
- A summary of how the prize funds would be used to benefit the career of the author (Note: a detailed budget is NOT required) – maximum 1 x A4 page.

- / Where an entry is by nomination, a commendation of the author must be provided by the nominator – maximum 1 x A4 page.
- Please note that copies of published or produced work are NOT required for this category.

Best Writing Award 2012 \$30,000

The Best Writing Award 2012 is for a piece of published or produced work of outstanding clarity, originality and creativity by a Victorian writer.

The work can be any genre or form for example, fiction, non-fiction, essays, plays, screenplays and poetry. There is no age limit for this award.

The Best Writing Award 2012 is supported by its sole patron, The Robert Salzer Foundation.

The recipient of this award will also receive Qantas international air travel to the value of \$2,500 (including GST).

What you need to know to enter this award

- Authors can apply for this prize in their own right or be nominated by publishers, agents or private individuals.
- / A separate entry form and fee must be provided for each additional application or nomination.
- / The entered work in this award must have been published or produced between 17 July 2009 and 16 July 2012.
- / Only ONE work per author may be entered or nominated for this award.
- / A shortlist of up to ten (10) finalists will be announced on 5 September 2012 at melbourneprize.org and displayed at the Federation Square finalist exhibition. The recipient will be announced on 7 November 2012 and published on the Prize website.

Material required for this award

Please provide six (6) stapled A4 copies of the following support material:

- / A description of the author's inspiration, research or background for the submitted work - maximum 1 x A4 page.
- / A summary of how the prize funds would be used to benefit the career of the author (Note: a detailed budget is NOT required) – maximum 1 x A4 page.
- / Please include six (6) copies of the submitted published or produced work with the material.

Residency - The University of Melbourne

A residency at the School of Culture and Communication, The University of Melbourne will be awarded, at the discretion of the judges, to either the recipient of the Melbourne Prize for Literature 2012 or the Best Writing Award 2012. Details of the residency will be decided between the recipient and The University of Melbourne following the announcement.

Civic Choice Award 2012 \$5,000

A public exhibition of the finalists in the Melbourne Prize for Literature 2012 and the Best Writing Award 2012 will be held at Federation Square between 5 and 19 November 2012.

This award will be given to the finalist with the highest number of public votes. Votes can be made using the online voting form, available at melbourneprize.org from the announcement of finalists on 5 September to the close of the Federation Square exhibition on 19 November. A voting form will also be available in the free catalogue, available during the exhibition.

The announcement of the winner of the Civic Choice Award 2012 will be made on 23 November 2012 at melbourneprize.org

/ Authors in both categories must be an Australian citizen or Australian permanent resident, and resident of the State of Victoria. / The decisions of the Awarding Committee will be final and no correspondence shall be entered into

/ The Melbourne Prize Trust reserves the right not to allocate the prize and award categories.

/ Work submitted for both categories must be by a living writer.

How to Enter

- 1.Choose the category more than one category may be entered.
- / Melbourne Prize for Literature 2012 / Best Writing Award 2012
- 2.Tear off and complete the entry form and attach the \$45 (incl. GST) entry fee where indicated. The entry fee may be paid using the following methods:
- / Personal cheque made out to the Melbourne Prize Trust
- / Online using PayPal to pay using this method visit melbourneprize.org/pay - please provide the PayPal receipt number where indicated on the entry form and print off the receipt and include it with entry material.

- / Australia Post money order made out to the Melbourne Prize Trust
- A separate entry form and fee must be provided for each application or nomination. A receipt for the entry fee will be issued by email.
- 3. Provide six (6) copies of the entry material required for the category entered.

- / Entry in the Melbourne Prize for Literature 2012 and Best Writing Award 2012 can be made by the author in their own right or by nomination by publishers, agents or private individuals.
- / More than one category may be entered. A separate entry must be completed for each prize and award application or nomination. This entry form is available at melbourneprize.org.
- / The work of the applying or nominated author must be published and/or produced and be the author's original work.
- / Work that has ONLY been published on the internet is not eligible for entry.

- / All work entered in either category of the prize must be in English.
- / Please provide all information requested on the entry form. If the entry process has not been adhered to, the Melbourne Prize Trust reserves the right not to accept an entry.
- / All entries and material will be handled in accordance with current privacy legislation.
- All communication, including acknowledgment of entries and the entry fee receipt, will be via email to the email addresses provided in the entry form. Where an email address is not provided, correspondence will be sent to the mailing address provided.
- / Copyright stays with the author of the entered work.
- / Authors making applications, or entries via nomination, warrant they do not violate the copyright of others' work or seek to defame the character of any individual or group.
- / The Melbourne Prize Trust reserves the right to use entry information, where applicable, for the purposes of making announcements, media activity or promoting and displaying the 2012 prize program. At all times, prior consultation will be undertaken with the finalists and winners.
- / Prize and award recipients should seek, if necessary, professional advice regarding their GST and tax obligations.



About the Melbourne Prize Trust and Annual Melbourne Prize

Launched in 2004, the Melbourne Prize Trust recognises and rewards excellence and talent, inspires creative development and enriches public life. The Trust achieves these aims by running the annual Melbourne Prize, which is funded by a collaboration of partnerships and patrons. The Trust is an Income Exempt Charity with Deductible Gift Recipient status.

The annual Melbourne Prize is one of the most valuable creative development initiatives of its kind in Australia. It runs on a three-vear cycle and rewards sculptors, writers and musicians in turn. The current cycle is:

/ Melbourne Prize for Urban Sculpture (2011)

/ Melbourne Prize for Literature (2012)

/ Melbourne Prize for Music (2013)

The Prize is unique, celebrating artistic excellence under the banner of Melbourne.

The major event of the annual Melbourne Prize is the free two-week public exhibition of finalists' work and the prize announcement held each November at Federation Square. The public have the ability to vote for a finalist to win the Civic Choice Award. The exhibition increases the public's exposure and access to the creativity of our community and enhances Melbourne's reputation as a cultural capital.

The origins of the Trust date back to the establishment of the children's garden precinct at the Royal Botanic Gardens Melbourne and the commissioning of The Magic Pudding sculpture in 2000.

Proceeds from the sale of limited edition miniatures of this landmark sculpture contribute to the Trust. Please contact the Melbourne Prize Trust regarding the miniatures.
